

Residential Counselor Job Description

ORGANIZATION OVERVIEW: Parrott Creek Child & Family Services supports children and families involved in juvenile justice, child welfare, substance misuse and behavioral health systems. Our mission is to help our participants identify strengths and develop skills that build stronger families and safer communities. We build effective partnerships to align services, maximize resources and provide an equitable and inclusive continuum of care.

POSITION SUMMARY: We are hiring multiple Residential Counselors to work with male and male-identifying youth at our residential treatment center outside of Oregon City. Located on 80 acres of forest, wetland and creek, our treatment facility is a wonderful and nurturing environment in which to take on this challenging yet hugely rewarding work. Parrott Creek is a leader in combining trauma-informed treatment models with restorative justice and mindfulness practice. Our vision is to become a regional center of excellence.

Residential Counselors work directly with the youth to provide a safe, secure and nurturing environment for youth. They do this by creating healthy relationships with our youth based on good boundaries between adults and youth.

POSITION TYPE: Full time; Days, weekends and Overnight Shifts, including holidays

PRINCIPAL DUTIES

- Major responsibilities of the role include individual and group skill building, engaging with youth during activities and helping youth find solutions to their own challenges. At its heart, we believe our children and families are smart, capable and doing the best they can with the resources they have available to them. Your job is to help our youth reach their full potential. We approach our social service from a non-judgmental, respectful perspective and these values extend to how we work collaboratively as colleagues.
- Residential Counselors work directly with the youth to provide a safe, secure and nurturing environment for youth. They do this by creating healthy relationships with our youth based on good boundaries between adults and youth.

Residential Counselors work as a team modeling feedback for youth and each other
as well as maintaining adherence to the agency's policies and procedures. Training
includes, but is not limited to, effective group and individual skill building,
de-escalation techniques, milieu management, appropriate supervision of youth,
facilitation of day to day residential living, activity planning and collaborative
problem solving.

- Able to stand 4-6 hours at a time.
- Computer experience, proficiency with Microsoft Office preferred.
- Ability to lift 50 pounds.

- Work cooperatively within a team.
- Have a valid Oregon Driver's License and good driving record.
- Be able to drive a 12-passenger van.

- Prefer experience working with/in BIPOC communities; understanding of and commitment to mindfulness practice; understanding of and commitment to anti-racism; support of diverse lifestyles and cultures; training or experience with Restorative Justice programs and practices.
